From the North, take Turnpike: Take exit 254 for FL-528 toward US-17/US-92/US-441 go 0.4 mi Keep left at the fork, to continue toward FL-528 E, go 0.3 mi, Keep right at the fork, follow signs for FL-528 E/Orlando International Airport/Kennedy Space Center and merge onto FL-528 E, About 10 mins, go 10.5 mi, Take exit 16 for FL-417 S toward Tampa About 1 min, go 1.0 mi, Merge onto Central Florida Greenway/Florida 417 Toll S, About 3 mins go 3.0 mi, Take exit 22 for County Rd 15/Narcoossee Rd About 1 min, go 0.4 mi, Turn left at Co Rd 15/Narcoossee Rd, About 10 mins, go 4.9 mi, Turn left at Cyrils Dr, About 2 mins, go 0.8 mi, Take the 2nd right onto Franklin Rd, go 0.3 mi, Take the 1st left onto Leon Tyson Rd, Destination will be on the left.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1 As used here "ASCA" means the Australian Shepherd Club of America, its Affiliate clubs and each of their Members, Officers, Directors, Employees, Show Chairs, Show Committees and Agents.

1.2. Exhibitor/owner, agree to abide by the rules and regulations of ASCA and any other rules and regulations appearing in the premium for this event.

1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the State in which the dog resides.

1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5. Exhibitor/owner releases ASCA, the ASCA Affiliate club (including its Officers, Directors, Members, and Event Organizing Committee), and site owner(s) (including its Officers, Agents, and Employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their Employees or Agents or any other persons.

ASCA® Service Membership and Tracking Number Application

In order to have ASCA® qualifying legs tracked and to receive ASCA® titling certificates, each non-ASCA® registered dog will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (minimum membership type of "Service" is required). ASCA® membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA® the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA® qualifying legs earned from 1/1/2003 until submission of application.**

➤ FREQUENTLY ASKED QUESTIONS ◀

Do I have to have a tracking number to compete?

No, you do not need a tracking number in order to compete in Agility or Stock.

You will need a tracking number to enter an Obedience trial or Tracking Test.

Your dog does not have to be a purebred to receive a tracking number from ASCA®.

Why would I need or want a tracking number for my dog?

If you would like to have your dog's points and titles recorded by ASCA®, and if you'd like to receive title certificates in the mail for your accomplishments, you might want to obtain a tracking number.

How much is the total cost for a tracking number?

In order to obtain a tracking number for your dog, you must be at least a "Service" member. The cost for Service Membership is **\$10**.

- Your membership is good for one year; however, it does not need to be maintained in subsequent years, unless you want to obtain another tracking number for another dog after your membership has expired.

This membership fee is **in addition** to the tracking fee of **\$10** per dog. A tracking number is good for the lifetime of the dog. If you only have one dog, the total cost would be **\$20**. For two dogs, the cost would be **\$30**, for three, the cost would be **\$40**, etc.
